After aforementioned transactions, the total number of own shares on November 1, 2024 amounts to 146,016 shares or 1.52% of the total outstanding shares.

Within this program (668,027), 522,011 shares remain to be bought back.

The re-start of the share buy-back program was announced on August 10, 2023 and is in accordance with the mandate given by the Extraordinary Shareholders' Meeting of May 16, 2023.
