After aforementioned transactions, the total number of own shares on May 27, 2022 amounts to 35,991 or 0.46% of the total outstanding shares.

Within this programme (781,900), 745,909 shares remain to be bought back.

The share buy-back program was announced on March 10, 2022 and is in accordance with the mandate given by the Extraordinary Shareholders' Meeting of May 18, 2021.
