After aforementioned transactions, the total number of own shares on September 30, 2022 amounts to 54,042 or 0.69% of the total outstanding shares.

Within this programme (781,900), 727,858 shares remain to be bought back.

The share buy-back program was announced on March 10, 2022 and is in accordance with the mandate given by the Extraordinary Shareholders' Meeting of May 18, 2021.
