

After aforementioned transactions, the total number of own shares on November 4, 2022 amounts to 55,481 or 0.71% of the total outstanding shares.

Within this programme (781,900), 726,419 shares remain to be bought back.

The share buy-back program was announced on March 10, 2022 and is in accordance with the mandate given by the Extraordinary Shareholders' Meeting of May 18, 2021.
